- To submit reports to the competent authority.

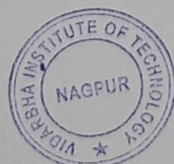
### 5. Grievance Redressal Mechanism


